Parking and Security: Betty reported that there are still some issues with parking. There has been a lot owners providing their data into Parking Boss since last month. The Board is to review the parking rules. Security: No report. There was discussion regarding people not stopping at stop signs. It was recommended that when people witness other people not obeying traffic law that those doing the observation contact the Bluffton Police at that time. It also mentioned that if people have videos of vehicles not obeying traffic laws, if those videos are sent to the Board and Management a search of the License Plate Cameras can be made to see if the owners of those vehicles can be identified.

Social and Communication: Patti will send emails to management regarding upcoming events on the Calendar and management will send blast out to the entire community.

Old Business: Robert reported that Atlantic Asphalt is to start repairs of the streets on May 27<sup>th</sup>. Betty reported that the walkway extension at the Buckwalter Entrance is complete. Betty requested approval to purchase a doggie pot to place at the walkway extension, Lynne moved to purchase a doggie pot, Jill seconded the motion the motion carried. Betty reported that the lighting at the area where the walkway extension is not working, Mike with Nitelites is to look into this and provide a quote.

New Business: Betty reported that there were issues regarding owners to install screen over garage openings. Patti read the Rules and Regulations and Architectural Design Standards, they both state that no garage opening can have a screen <u>unless</u> it is approved by the ACC.

Management is requested to send a blast to the community regarding Article 11 Use Restrictions.

Management Report: Street repairs are to start this month, management will get prices to raise the level around the catch basin behind 21 Torrey Lane. The revised report from Nitelites was discussed, the Board decided to hold off on making those reports until we get the proposal to repair the right side lighting. Once the streets are repaired the company that installed the walkway will do a review of the issues that need addressing with the sidewalks and give us a proposal. Other action by Management was discussed.
